Symposium "Returns from the Americas (1750-1914)" 52 International Congress of Americanists Seville, 17-21 July 2006

This Symposium intends to be an open and plural academic forum for scholars of diverse fields to engage in the fruitful interchange of ideas. In this meeting, we will discuss the multiple ways that returns from the Americas have affected European society and economy from the second half of the eighteenth century until World War I.

The Symposium is the second of its kind. It follows up on a previous meeting, "Returns from the Americas in the Nineteenth Century: Men, Money, Culture, and Politics," which took place in Barcelona on 18 June 2004, sponsored by the Jaume Vicens Vives Historical Institute of the Universitat Pompeu Fabra and the Department of History and Economic Institutions at the Universitat de Barcelona. This second meeting differs from the first insofar as this symposium goes beyond the Spanish context to address Europe as a whole.

"The bloody Writing is for ever torn': Domestic and International Consequences of the First Governmental Efforts to Abolish the Atlantic Slave Trade" Call for Papers

On August 8-12, 2007, the Omohundro Institute of Early American History and Culture, in cooperation with UNESCO, the Gilder Lehrman Institute of American History, the W.E.B. Du Bois Institute for African and African American Research, the Reed Foundation, Inc., and the Wilberforce Institute for the

Study of Slavery and Emancipation, will convene a major international conference in Ghana, West Africa. The aim of the meeting is to examine the national and international contexts of the transatlantic slave trade at the end of the eighteenth century; the circumstances that led to decisions by some of the trade's original instigators and greatest beneficiaries to outlaw participation in it; and the social, political, economic, and cultural consequences for all the inhabitants, slave and free, of the kingdoms and nations involved, of actions that ultimately abolished one of the pillars of Atlantic commerce.

The conference will be multi-disciplinary, and the program committee welcomes proposals from scholars in all appropiate fields: history, historical anthropology, archaeology, literature, philosophy, and social sciences. Please submit written proposals of three to five pages outlining the subject, argument, and relevance to the conference themes. Proposals for individual papers and for panels are welcome; submissions may be in English, French, or Portuguese. Include curriculum vitae. Call for contributions Revisiting Slave Narratives II «Les Carnets du Cerpac» Paul Valéry University, Montpellier III (France)

An international colloquium was organized by the Cerpac and held at Paul Valéry University in April 2003 that focused not only on the African-American neo-slave novels published in the 1960s but also on the more recent neo-slave narratives written in the 1980s and 1990s by African, African-American and Caribbean writers such as Fred D'Aguiar, David Dabydeen, Charles Johnson,

Caryl Phillips, among others. After the success of the colloquium and its proceedings (2005), a second volume of papers entitled "Revisiting Slave Narratives II" is going to be published to cover some of the many writers not included in the first. Novels, young adult fiction, short stories, poems and plays can be examined in relation to the original 18th and 19th century slave narratives and to the 1960s first wave of neo-slave novels.

Contributions about visual artists like Renée Green, David Hammons, Isaac Julian, Glenn Ligon, Kerry James Marshall, Adrian Piper, Kara Walker, are also welcome. This publication should interest all those working in the Caribbean field, anglophone or francophone, as well as the African and the African-American/Canadian field, in Literature, Culture Studies or the Visual Arts.
